The Severn River Lions Club Board of Directors Meeting was called to order by KL Sue Parks at 7:35pm with seven Board Members present.

King Lion Announcements: KL Sue Parks stated that there is not a quorum. Any voting will have to be postponed.

Secretary's Report: The minutes from the January 9th Board Meeting were accepted as read. The minutes of the January 9th Foundation Meeting were accepted as read. The minutes of the January 16th Special Board Meeting were accepted with a change. Nancy Burns was added to the list of Member Attendees.

The minutes of the February 6th Board Meeting were accepted with changes. The following was added to the Cruise Report: "proceeds to be granted to the Low Vision Center at the Wilmer Institute, Johns Hopkins Hospital for use by children from Maryland". Minutes of the February 6th Foundation Meeting were accepted as read.

Treasurer's Report: Lion Bill O'Neil reported financials as of March 7, 2007:

The March Fruit Sale and April Bull & Oyster Roast activities will be the last fund raising monies to be added to the Activities Checking Account for this fiscal year. Lions Nancy Burns and Ollie Wittig will assist Lion Bill to recommend spending for the Activities Checking Account to bring it to the \$10,000-\$11,000 level for transfer to the next fiscal year Budget.

Old Business /Reports:

Meal Policy - Lion Bill O'Neil recommended that all "Active" Members be charged for all meals. Permanent exceptions will be considered on a case by case basis as required based on medical or dietary restrictions. Those "active" members who receive exception will pay a \$5 quarterly meal surcharge. Others will be considered for "MAL" or "Affiliate" status. No vote taken.

Membership – Lion Ken Tschantre reported that Lion Janice Abney will be resigning for health reasons. Lion Joe Earley will change membership status to "MAL" for reasons of health effective April 1, 2007. No vote

taken. Jack Latham died March 12, 2007. A memorial service is being held at Woods Church on March 19, 2007.

Two applications have been received for membership - Nancy Earley, sponsored by King Lion Sue Parks, and Miguel Sanchez, sponsored by Dick Bloomquist. No vote taken. Mike Crowell, sponsored by Nancy Burns is still a possibility. We will convene a special board meeting prior to the 3/20/07 General Meeting to deal with membership requests.

Fruit Sale – Lion Chuck Horne reported that Temple oranges and grapefruit are expected to be shipped. Reports are that the e-mails have not yet been sent out.

SPHA Cleanup – Lion Chuck Horne suggested that we utilize our new truck to clear out the Health Center on Fruit Sale day.

West Arundel Club: Charter Night is still scheduled for June 1st. Gifts from SRLC are still to be determined. Lion George Councill is building a podium. WA Club meetings will be changed to the fourth Tuesday of the month.

Cruise Update – Lion Nancy Burns reported that no one has yet signed up from the several Clubs that have shown interest. April 3rd is the cut-off deposit date to hold specific rooms. A full refund is available up to August.

Bull & Oyster Roast – Lion Nancy Burns reported that Hometown Hearth will be donating a grill for the auction. Only 12 tickets have been sold to date. Dick Maurer will check with LCI about insurance needs.

Other – KL Sue Parks has extended the life of the Truck Replacement Committee to consider such things as lettering, maintenance schedule, overall utilization etc.

New Business:

Lions Quest – Lion Nadja Muchow reported that the estimated budget is \$4,000. The amount depends on the number of teachers. Several clubs have expressed interest in sharing the cost. A pledge of support is needed. Subject tabled for the next Board Meeting.

Scholarship – Lion Ollie Wittig reported that the Committee reviewed 17 applications from the Severna Park and Broadneck High Schools. A preliminary selection has been made pending reports from the high schools about college acceptance information. Final selections should be made by the end of March. Special thanks to Lions Mary, Roger and Trent, Jan Wittig, too for their contributions. Lion Ollie proposed that we invite the scholarship winners to an April or May General Membership Meeting.

Pre-K Vision Screening sessions at St. Martin's in the Field are scheduled for March 21, 22.

Possible Fund Raiser – VDG Dick Bloomquist reported that one of the District 22A Clubs has set up a dumpster to collect newspapers and magazines for re-cycling and the revenues are up to about \$300 per month. The idea will be sent to the Fund Raising Committee for further study.

Internet Tool – VDG Dick Bloomquist reported on a special software program called "Members Now" that functions as a "sell/pay" program to support fund raising activities such as our Bull & Oyster Roast and Fruit Sales. The web address is "membersnow.com". Discussion was tabled for a future Board Meeting.

Calendars of Events – KL Sue Parks proposed meeting date changes. Move the May 15th General Membership Meeting to May 22nd to avoid a conflict with the Convention. Change the July, 2007 meetings schedule to July 10th and 24th for General Membership and July 17th for the Board Meeting.

MD Convention Delegates – KL Sue Parks, Lions Nancy Burns, Nadja Muchow, Dick Maurer, Dale Strait, Rhine Jager and as a PDG – PDG Bob Muchow. Alternates to include: Lions Oriey Glenn and Bill Zelenakas

Other – Lion Dale Strait reported on the March 31st Eye Glass Sorting event and called on all "Box Sitters" to bring their glasses to Lion Ollie Wittig.

Lion Roger Knauth moved to adjourn at 9:05pm. The motion was seconded by Lion Nancy Burns and unanimously approved.
