

Please note: We plan to publish 8 newsletters during the year -Jan/Feb, March, April, June, August, September, October and Nov/Dec.



WORKING WITH SPAN, HELPING OUR NEIGHBORS IN NEED

Recently the Severn River Lion Board approved donating \$1,000 to SPAN as an ongoing effort to help those in need during the pandemic. As a result, the donation was broken down into \$100 gift cards then distributed to local families. In addition to the donation SPAN responded with a letter of thanks and provided a news release in the Village Voice (locally known as the "crab wrapper" per Lion Dick M.) telling the community of our donation.

Do you know of SPAN's beginning?

On April 2, 1990, the Severna Park Assistance Network (SPAN) opened its doors to local area families in crisis. SPAN was formed because of the concern on the part of the ministers in the Severna Park area with regard to the growing demand for emergency help, the need to identify the people seeking help, and a process to help those people in a dignified and expeditious manner. Before that, those needing assistance would be forced to go from church to church. SPAN enabled them to find that same resource in one convenient place.



Since then, SPAN has been serving our neighbors to help them through a critical or emergency situation such as hunger, utility turn-offs, court-ordered evictions, and prescription/ medical needs. We have expanded beyond Severna Park, so SPAN is now an acronym for Serving People Across Neighborhoods.

SPAN's primary service areas include: Severna Park, Millersville, Arnold and Broadneck. SPAN's secondary service areas include the surrounding communities of Crofton, Crownsville, Odenton, Gambrills, (requires referral Crofton Christian Caring Council), Pasadena and Glen Burnie (requires referral from NCEON), Linthicum, and Severn.

In order to receive assistance all clients must have a current Maryland ID with current address or change of address card, a referral (if needed), a utility turn-off notice, or disposition (for evictions) signed by a judge.

SPAN is located at 400 Benfield Road, behind Our Shepherd Lutheran Church, in Severna Park. 





Now is the time to be asking what next! In 2018 LCI created MyLci replacing the M&A report. MyLci also requested membership changes and service projects etc. A short time later MyLion was created for Lions & Leo Clubs to report service project information. Leaving MyLci for membership reporting.

Is it simply; to those recalling M&A reports, there could be an adrenalin rush at times but, the final outcome is worth the effort?

So here is the easy path. Once the 1. Club President, 2. Secretary, 3. Service Committee Chair or 4. Club Administrator log onto MyLci membership changes etc. can be entered. The same Lions will also be able to report into MyLion our service projects, hours and dollars spent.

Special Note of interest: Once MyLci is opened there are two areas (other or global causes) for the information to be entered. **Other** - will reflect areas such as: Fundraising, Health & Wellness, Meetings/Administrative and Service Activities. **Global Causes** – found in the **drop-down** section allowing for entries be entered under five (5) LCI Global Causes: 1. Vision 2. Diabetes 3. Hunger 4. Environment 5. Childhood Cancer.

And now as a former club secretary I now understand the task at hand using MyLci and MyLion.
